2. I am aware of the risk, hazards and danger of personal injury, disability and/or death as a result of participation at Monkey Joe's.
3. In consideration for the admission of my child, I hereby release, waive and forever discharge and covenant not to sue **EXELCOLLE ENTERPRISES, INC.** d/b/a Monkey Joe's and its owners, agents, employees, officers, directors, trustees and all other persons or entities acting on its behalf, from any and all claims, actions, damage liability, cost or expense including attorneys fees which are related to or arise out of or in any way connected to my child's participation or use of the facility.

By the execution of this agreement, it is my intention to assume all risk of injury and do hereby surrender and waive any rights to sue or exercise any legal right to seek damages against **EXELCOLLE ENTERPRISES, INC.** d/b/a Monkey Joe's, its owners, agents, employees, officers, directors and/or all other persons or entities acting on its behalf.
5. I acknowledge that my or my child's participation in activities at Monkey Joe's is strictly voluntary. I hereby certify that I'm over 18 years of age, I have carefully read the foregoing covenant not to sue and acknowledge that I understand and agree to all of the above terms and conditions. Prior to signing this agreement, I have had an opportunity to ask any and all questions. I am aware that by signing this agreement, I assume all risks and waive and release all substantial rights that I may have and possess.
